



# ARTICULATION AGREEMENT between BRISTOL COMMUNITY COLLEGE and ROGER WILLIAMS UNIVERSITY

## **Statement of Purpose**

The purpose of this Articulation Agreement is to allow a smooth and successful transition between Bristol Community College (Bristol) and Roger Williams University (RWU) for students completing the Bristol Business Transfer program and pursuing a bachelor's degree in Management by identifying the transferrable credits from the Bristol Business Transfer program and specifying the courses needed to complete an RWU bachelor's degree.

#### **Program Details**

Students pursuing the Management Bachelor's Degree at RWU would complete the Business Transfer program and transfer into RWU with an A.S. Degree. Students may take electives to earn a minor or secondary major. Total credits transferable from Bristol's program: 62. Total credits earned between Bristol and RWU: 120-122.

#### **Business Administration**

Bristol students completing the Associate in Arts in Business Administration Transfer with an A.S. degree could transfer in 62 credits.

Courses Taken at BRISTOL leading to an Associate Degree: See attached Exhibit A

Courses Taken at RWU (during a two-year period leading to a Bachelor's Degree in a Business Major): See attached Exhibit B

Students can use electives to earn a minor or a double major. Total credits earned at RWU: 58-60.

Total credit hours earned between Bristol and RWU: 120-122

#### Terms and Conditions of Transfer:

1. RWU agrees to consider Bristol associate degree graduates who have earned a grade point average of 2.40 or higher (on a 4.0 scale) in their associate's degree programs for acceptance in RWU's program; it being understood, however, that such students must otherwise meet the qualifications of the Business Administration program at RWU to be accepted for enrollment therein.

- 2. Transfer students will receive academic credit for all college-level courses applied toward the requirements of the associate degree. A maximum of seventy-five (75) credits will be accepted for transfer.
- 3. Non-credit or remedial courses adjudged by RWU to be below college level may not be accepted for transfer.
- 4. It is understood and agreed that if a student does not have the foundation or skill to enroll in an upper level course because they have not taken introductory courses, they will be required to take any necessary prerequisite(s). Therefore, each student transferring into RWU hereunder may not complete requirements for the baccalaureate degree in four semesters.
- 5. The RWU catalog contains all information about degree requirements. Students wishing to plan their associate degree program to ensure meeting prerequisites for upper level courses are encouraged to communicate early with the transfer counselor at RWU to secure specific information about transfer credits.
- 6. This Articulation Agreement sets forth the current major offerings at RWU's Gabelli School of Business. Bristol and RWU acknowledge and agree that it is their intention that this Articulation Agreement apply to any future major offerings at RWU's Gabelli School of Business, provided that such major requirements and credits are comparable to those presently offered.

#### Miscellaneous Terms

- 1. The parties will review this Articulation Agreement annually, and this Articulation Agreement may be revised only by mutual written agreement.
- 2. This Articulation Agreement is effective as of December 6, 2024 and is applicable to eligible students in the next semester of enrollment.
- 3. This Articulation Agreement shall continue in effect unless terminated, for any or no reason, by either party with at least thirty (30) days' written notice to the other party. Should this Articulation Agreement be terminated and such effective date of termination occur before admissions decisions have been completed for any potential transfer of Bristol students to RWU, the parties agree to continue all terms of this Articulation Agreement until such admissions decisions are completed.
- 4. Except as otherwise provided in this Articulation Agreement, each party shall be responsible for, and shall bear, its own costs and expenses incurred in connection with this Articulation Agreement.
- 5. Students who seek to utilize this pathway can apply to RWU for free using the RWU Rapid Application. If students choose to utilize the Transfer Common Application, they may reach out to RWU Admissions for a transfer application waiver.
