Objectives:

- 1. To attract qualified students to Bristol Community College and Bridgewater State University.
- 2. To promote and facilitate an efficient transition of transfer students between institutions.
- 3. To provide specific information and guidelines for transfer students.
- 4. To encourage academic coordination and cooperation, including curricular reviews, on-site visits, and joint academic advising for students attending Bristol Community College.

Stipulations:

- 1. Bridgewater State University guarantees acceptance of Bristol Community College students who complete the Associate Degree program in Elementary Education, with an overall GPA of 2.8 as outlined in this document, and meet all criteria of the *MassTransfer* Program (see below).
- 2. At least one-half of a student's academic major as well as a minimum of thirty semester hours must be completed as a student of Bridgewater State University. BSU accepts up to 69 credits from a community college.
- 3. Students admitted into the baccalaureate program are subject to the academic policies of Bridgewater State University.
- 4. Students in EDU 130 will complete 10 hours of pre-practicum observation. Additionally, students can expect to invest 10 hours into service-learning/community-based learning in EDU 225.

Mutual Responsibilities:

- 1. Both institutions agree to maintain current listings of the course equivalencies. This will be the responsibility of the two designated representatives.
- 2. Bristol Community College and Bridgewater State University will incorporate a summary of this agreement into official publications and web sites.
- 3. Bristol Community College and Bridgewater State University agree to encourage qualified students to participate in this program by providing information, advising, and other assistance required to foster a seamless transition from Bristol Community College to Bridgewater State University.
- 4. Applicants applying under this program shall be eligible for the same financial aid consideration as other entering students. Students transfer with junior status with regard to financial aid and registration.

Review/Revision:

Review of the contents or implementation of this agreement will occur whenever requested by either party through the designated representatives. Substantive changes in the courses or program of either institution will evoke review processes. Revisions must be mutually agreed upon, with one-year notice prior to termination of the agreement.

MASSTRANSFER PROGRAM:

WHAT ARE THE BENEFITS FOR COMMUNITY COLLEGE GRADUATES?

Benefits for students who complete approved associate degrees under *MassTransfer* are:

Minimum Final GPA	Benefits
2.0 GPA	No admission fee or essay; Guaranteed, full transfer of credits applied to the bachelor's degree (including D – 1.0 grades); and Automatic satisfaction of the general education requirements at the receiving institution, with the receiving institution able to add no more than six additional credits/two courses, if admitted.
2.5 GPA	All of the above benefits, plus guaranteed admission
3.0 GPA	All of the above benefits, plus MassTransfer Tuition Credit

Stipulations: If the student changes his or her major or if the linked baccalaureate program requires a higher grade point average or specific courses which are required of native students, the *MassTransfer* student must meet these requirements. **Secondary Education requires a 2.8 GPA overall and in the major to be admitted to Professional Educator (teacher licensure) program.** PROF Ed admission is in turn required to advance to EDHM 300-400 level courses. If because of space or fiscal limitations the receiving institution does not admit all qualified applicants to a given major or program, the receiving institution will use the same criteria for *MassTransfer* applicants as it does for its native students.

In keeping with the *MassTransfer* Program:

- As a participant in the *MassTransfer* Program, the Bridgewater State University application fee is waived when students complete the BSU online application.
- Developmental courses and courses with D- will not transfer.
- All MassTransfer requirements must be met prior to enrollment at Bridgewater State University.
- The grade "D" will be accepted toward the Baccalaureate Degree but will be credited toward the major only if a "D" grade will count for native students who began at BSU. BSU Secondary Education requires a minimum grade of C- in all courses required for the major.
- Student will be eligible for MassTransfer Tuition Credit with GPA of 3.0 or higher.

Department: Secondary Education and Professional Programs

High School (8-12), Middle School (5-8), PreK-12 Specialist

The Department for Secondary Education and Professional Programs offers a Bachelor of Arts degree in Secondary Education. This major is designed for undergraduate students intending to teach at the middle and/or high school grade levels (i.e., grades 6-12). The Secondary Education, BA is a double major program and requires students to be concurrently enrolled in another major from an appropriate academic discipline. Graduates from the program will be eligible to apply for initial Massachusetts licensure in their respective content area(s), listed below:

Biology (Teacher of Biology 8-12)
Chemistry (Teacher of Chemistry 8-12)
Dance (Teacher of Dance all levels)
Earth and Space Science (Teacher of Earth and Space Science 8-12)
English (Teacher of English 5-12)
History (Teacher of History 5-12)*
Mathematics (Teacher of Mathematics 5-8 or 8-12)
Physics (Teacher of Physics 8-12)
Spanish (Teacher of Foreign Language: Spanish 5-12)
Theater (Teacher of Theater PreK-12)
Visual Art (Teacher of Visual Art PreK-8 or 5-12)

Additionally, all undergraduate students preparing for a career in education in the Commonwealth of Massachusetts must meet the requirements of the Massachusetts Department of Elementary and Secondary Education. Students may not register for 300-400 level courses in the Secondary Education major until they have met all admission criteria (including a minimum overall 2.800 GPA and successful completion of the appropriate Massachusetts Tests for Educator Licensure®). Note: This allows greater continuity in course work and also reduces stress during first BSU semester. Students may take it as early as first semester at BCC.

Admission Requirement:

Students may declare a major in Secondary Education at any point, provided they are concurrently enrolled in a liberal arts or sciences major in the content area they plan to teach. All undergraduate students seeking licensure must consult the College of Education and Health Sciences section of the Bridgewater State University catalog for information pertaining to admission to a professional education program and the state regulations for the licensure of educational personnel and important institutional deadlines. BSU strongly recommends students declare Secondary Education major upon transferring to BSU so that they receive advising in the major immediately.

^{*}Please note: students intending to teach history must enroll in both the History BA and the Social Studies minor.
