Stonehill College and Bristol Community College Transfer Guarantee Agreement

This Memorandum of Agreement (MOA) between Stonehill College and Bristol Community College (Bristol) established the conditions for guaranteed admission as full-time, undergraduate, degree seeking students. The purpose of this agreement is to provide all Bristol Community College students with an expectation of their admissibility to each of Stonehill's four-year degree programs, as well as an expectation of a minimum level of institutional funding designated to increase price transparency.

Bristol students meeting the criteria outlined below will receive:

- Guaranteed admission into either the Leo J. Meehan School of Business or the Thomas and Donna May School of Arts and Sciences.
- A guarantee that all credits taken at Bristol Community College for which the student received a passing grade (C- or higher) will transfer to Stonehill College.
- Receive a minimum 50% reduction in the tuition charge at the time of their initial semester of entry. *

Student Responsibilities:

In order to be eligible for the commitments outlined above, Bristol transfer candidates must:

1. Have achieved a minimum of a 3.3 cumulative grade point average in at least five (5) non-technical courses at or above the 100 level and have not received any individual grade below a C- throughout their period of enrollment at Bristol.
2. Submit a completed Transfer Application by the published deadline for each entry term including the subsequent submission of all currently required supporting application materials.
 - a. All application fees will be waived for students applying from Bristol.
3. Have maintained good academic and disciplinary standing during their time at Bristol as confirmed by submission of the College Report Form to be completed by the Vice President of Student Services and Enrollment Management's Office at Bristol.
4. Submit the Free Application for Federal Student Aid (if applying for additional financial assistance) by currently published application deadlines.

Institutional Responsibilities:


To support students in their transfer to Stonehill each institution commits to the following:

1. Stonehill and Bristol Community College will each designate transfer-student liaisons who are empowered to provide detailed guidance and support for students interested in participating in this agreement.
2. Stonehill will engage in monthly recruiting and transfer advising sessions to take place on the Bristol campus. These events will be scheduled in collaboration with the designated Bristol liaison.
3. Stonehill will provide detailed course credit evaluations to students at the point of application.
4. Stonehill will develop, monitor, and update a digital library of existing Bristol courses along with their pre-approved course equivalent at Stonehill.

5. Each institution will collaborate on the development of print, web, and email marketing resources to assist in highlighting this partnership to prospective students.
6. This MOA is subject to annual review, as well as a formal request for revision, which can be accommodated based on mutual consent of the signing parties or their designee.
7. This agreement may be terminated by either institution by providing written notice to the signatories below. Such notice must articulate an effective date of termination, which can be no sooner than one calendar year from the date that the initial notice to terminate is provided. Termination shall not affect students who have applications pending or have already been accepted into Stonehill.


