



University of Massachusetts Global Scholarship Program

University of Massachusetts Global (UMass Global) offers educational programs regionally accredited by WASC Senior College and University Commission (WSCUC) and has established a University of Massachusetts Global Scholarship Program designed to support organizations with their student and employee education development efforts. **Bristol Community College** wishes to participate in the scholarships available through this program as part of its student and employee benefits.

The Parties acknowledge the following:

1. University will offer and fund UMass Global Scholarships to Organization's employees and students, and constituents, as further defined below. Constituents are defined as Bristol Community College students, students' spouses and dependents, employees, employees' spouse and dependents, new student enrollments. Other UMass Global scholarships, military funding and discounts may not be combined. As consideration for the scholarships noted below, organization agrees to implement the tactics and strategies as detailed on the attached marketing/project plan.
2. University of Massachusetts Global Scholarship Offering:
 - **Undergraduate hybrid and traditional online degree programs:** Scholarship of ten percent of tuition rate
 - **University of Massachusetts Global MyPath™ degree programs:** Scholarship of ten percent of UMass Global MyPath™ program tuition rate
 - **Master's hybrid and traditional online degree programs (except as specifically noted below):** Scholarship of ten percent of tuition rate
 - **Master of Arts in Educational Leadership and Administration:** Scholarship of twenty percent of tuition rate
 - **Master of Arts in Teaching and Teaching Credentials program:** Scholarship of fifteen percent of tuition rate
 - **Ed.D. Organizational Leadership program:** Scholarship of ten percent of tuition rate
 - **RN to BSN and DNP:** Scholarship of ten percent of tuition rate
 - **Organization Custom Off-site Cohorts:** Scholarship of twenty percent tuition (as approved by University)
 - **Master of Arts, MFT:** Scholarship of fifteen percent of graduate tuition rate
 - **Advancement Pathway:** Scholarship of ten percent of tuition rate

Scholarships apply to new students who begin their UMass Global program during the 2022-23 and 2023-24 academic year, which is Fall 1, 2022 through Summer 2, 2024. Scholarships noted above are for the 2022-23 academic year. Scholarships available by program and percentage of tuition may change for the 2023-24 academic year. Total scholarship amount may vary by student depending on academic history and program of choice. UMass Global tuition rates are subject to change. The scholarship cannot be combined with any other allowance or special pricing, including military tuition rates. The scholarship offered will depend upon the student's catalog year or date of submission of scholarship application,

whichever is later, and will remain fixed for the duration of the entire academic program so long as the student does not miss more than twelve (12) consecutive sessions, continues to make satisfactory academic progress, and remains in good academic and financial standing in accordance with University's existing catalog. Students must fill out a scholarship application form and submit the same to Admissions. Scholarships will be applied to the current active session/trimester based on date of receipt of the scholarship application and **cannot be applied retroactively**. All Organization students, employees and their spouses and dependents, currently enrolled with University, must acknowledge the scholarship opportunity within the session immediately following the UMass Global Scholarship Program start date. There is no discount on textbooks or fees associated with any University program.

As a partner of University of Massachusetts Global (UMass Global), your students, employees and their spouses and dependents shall be entitled to a 10-20% scholarship as detailed in this agreement. UMass Global shall provide, in a turnkey fashion, the following promotional materials to promote UMass Global and the scholarship to your students, employees and their spouses and dependents. Your partnership commitment shall be to actively communicate and support the promotion of UMass Global, on a continuing and regular basis as detailed below.

It is important to note that your students, employees and their spouses and dependents shall be required to complete and return a scholarship application form and provide proof of employment, student enrollment or relationship to employee or student, to UMass Global as part of the enrollment process. That proof shall be in the form of Bristol Community College ID.

Bristol Community College agrees to make best efforts to fulfill the following elements, as provided by UMass Global, to facilitate promotion of UMass Global to students, employees and their spouses and dependents:

- **UMass Global Partner Landing Page:** Upon launch, Partner will post and continue ongoing distribution. Landing page, application, and umassglobal.edu unique coded links provided. Partner logo can be added to the landing page, example - www.umassglobal.edu/partnership/premiere
- **Partnership Launch email with Scholarship Instructions** – Upon launch, Partner will agree to distribute a Partnership Launch announcement email to include scholarship instructions. Upon request, UMass Global can provide social media assets to promote the Partnership, and can also provide promotional materials in printed form via Flyers or Posters.
- **Logo:** Upon request, Partner may provide logo for UMass Global to list Partnership on our website and for use in other marketing materials (with Partner prior approval).
- **Monthly Information Sessions:** As possible, partner will distribute dedicated UMass Global email to students and employees once per month to contain invitations to webinars, information sessions and other details. Upon request, UMass Global can additionally provide customized Information Sessions for students and employees.
- **Scholarship Instructions.** Partner will also make scholarship instructions available upon request for students and employees and will agree to distribute occasionally to students and employees as a reminder of the Partnership.
- **Onsite Tabling Events:** As opportunities arise, Partner will allow UMass Global to table at various student and employee events to include student and employee benefits events.

- **Open enrollment and New Hire packets:** As possible, Partner will agree to promote UMass Global at student and employee enrollment events and in packets.
- **Press Release** – Upon request, UMass Global can provide a template or custom press release to announce Partnership and student and employee educational benefit offering.
- **Career Services:** Upon request, Partner may post job openings with UMass Global's Career Services site powered by Handshake. If you already have an employer account, please add UMass Global to your list of schools. - **Professional development, corporate training and / or education needs assessment:** Upon request, UMass Global can provide and facilitate a survey to assess the educational needs of workforce. 
