SIT DOWN WITH JASIEL F. CORREIA

SETTING THE RECORD STRAIGHT WITH THE MAYOR OF FALL RIVER

A few weeks ago, when I emailed the mayor's office for an interview, I honestly didn't expect a response. I write for the community college's paper with a staff of four. We have 12 followers on Twitter. The paper was planning on covering the second indictment of the mayor in our October issue, but we never expected the mayor to agree to an interview, so we were ecstatic to get the chance to sit down with the man who recently made national headlines. Within a few days of my first email, I had an interview with the top man in Fall River, who is currently facing his second indictment since taking office.

For the uninitiated, Fall River Mayor Jasiel F. Correia II (age 27) was arrested just days before the preliminary election on charges that allege he extorted marijuana vendors of hundreds of thousands of dollars. The city council voted to temporarily remove him from office, but Correia has repeatedly refused to relinquish control to City Council President Cliff Ponte.

When I got to city hall, I wasn't sure what to expect. In reading the headlines on the mayor, I got the impression I was about to meet some sort of young Buddy Cianci. I half expected there to be lawyers in the room. What I found was very different.

When the mayor walked into his office to meet me, he seemed completely relaxed, holding a cup of coffee from the Pink Bean. He didn't seem at all like a man that could be facing possible jail time. We talked for about 45 minutes, on everything from his rise to city council, to his current legal troubles.

You went to Providence College for political science?

A: "I did. Yea, went to Providence College. Went to Bishop Connolly, and actually, Bishop Connolly at the time had a dual enrollment system with BCC [Bristol Community College]. So I actually took some classes at BCC. Both my parents went to BCC. That's where they met, which is pretty cool. Little fascinating fact. Had BCC not existed, and they didn't go, I probably wouldn't be born. So BCC is a very important part of our lives. And as a

kid, I would ride my bike all through BCC, all the little paths and different parts of the campus."

How did you wind up on the city council?

A: "So, I decided to run for city council. I came in tenth place, out of nine spots that were available. Just missed it by 300 votes. But then a turn of events--so, the mayor at the time plucks the top vote getter, and made her a city administrator, which by city charter allowed me to bump into the ninth spot. So, it was kind of like a default, but had I not worked my butt off and got that tenth spot, then I wouldn't have been able to serve."

What was it like being on the council as a young person?

A: "On the council, I was kind of like the fresh voice, obviously being a young person. I was

like 20-, 21-years-old at this time. I was young. I couldn't even drink at fundraisers. It was crazy. I prepared myself for each meeting, tried to bring a fresh perspective, and just tried to do a good job.

How did you go from the council to the mayor's office?

A: "Sam Sutter had just won the recall election. And I just really didn't... I wasn't a fan of his. I really wasn't, and I am the type of person that if I see something that I don't care for, I'm going to either try and make a difference, or go all the way in and maybe fail, but at least try. So, I decided to throw my hat in the race. And I was 23-years-old, 22 actually, when I started thinking about running for mayor. And then I asked around a bunch of people, and a lot of people that are high up in the city, people that hold different positions of authority. Kind of were like, you know, you can't win without this person's support. You can't win without this. You're too young. How's a 23-year-old going to run a city? This doesn't make sense. Baba blah...you don't have the money. And I said, I said, 'I understand all that.' But I said, 'This guy is not going to win.' I went to school for political science. I understand how elections work. This guy put in a fee. He goes to no events. He's like a ghost. People actually call him a ghost. And I just said, 'This guy's not going to win.' So you know, I campaign, I have these debates with Sam, and I won. I was elected in 2016."

What have you been able to accomplish so far?

A: "Just to give you a few of those examples. In 2016, when I became the mayor, we have something called a stabilization account, called a stab fund that is basically like the city's savings account. We had \$500,000, when I started in 2016. In 2019 right now, we'll have \$9 million in that account. So in just three years, we went from \$500,000 to a \$9 million surplus. And this is the thing that I think is important, especially for students like at BCC, anyone could have done this. But people older than me, people that have had more experience than me, for whatever reason, didn't do it. I did."

Why do you think the people before you weren't able to accomplish this?

A: "I think it's a combination of things. I think, one, they took the political way out. The politically expedient choices, as opposed to the best choices for the city long term. I'll give you an example.

Unions are very big. Unions are very, very important. So one of the things I did to save all this money, is I privatized trash collection. So I, I took the union, I sat them down. I said, 'Look, we're not going to continue with unions, for trash collection. We have unions for police and fire, for teachers and everything else, but for trash, we're not going to have a union. Because this is breaking the budget. It's leading to the taxpayer owing this money.' And this is very important, because people attacked me. This is the problem. When I decided the privatized trash, I had people attack me because my age. I had a union guy, union member. He was like the leader, and he went out there publicly and said, 'He doesn't have a family. He doesn't have kids. So he doesn't know the value of labor, of earning a good wage That's a cop-out to say that because of my age, because I don't have kids, that I don't know the value of labor and the value of a good wage... Other mayors didn't want to take on the unions. Other mayors didn't make the right choices. You have to make tough choices."

Our conversation turns towards the most recent charges, that the mayor claims are unfounded.

You are saying the allegations against you are completely unfounded?

A: "They absolutely are. This is the question, how

does someone become a target of investigation? So think about it, I beat a district attorney. Does a district attorney have connections at the FBI office at Lakeville? Probably. I then beat Linda Pereira, a longtime city councilor, who admitted on the radio that she called the FBI herself. So what you have here is a politically motivated investigation, where they started with a conclusion. And then they fit pieces in to get to that conclusion. But that conclusion is not a guilty verdict. No one has even heard my side. No trial yet has happened. No judge has looked at the facts. All it has been is one-sided allegations. They didn't provide any evidence. They didn't show a document that said here's his bank account. He put all his money in the bank. Where's the search warrant? We all watch TV and see the FBI come with the jackets... how come they never storm city hall? It would have made a nice publicity for them. How come they never raided my house? These are very serious allegations, but yet, they're just based on people's word. They're not based in any fact. They'd find any evidence."

You think it is all hearsay?

A: "It's all hearsay! It's this guy's in trouble, so to get out of trouble, he says he gave the mayor a bribe.

Hey, where's the bribe? Where's the money? And it's all surrounding marijuana conveniently. So here's a young guy who became a mayor, who's done a good job, who opened the doors for marijuana. And all these people are upset that I open the doors for marijuana. So they want to get me because I did that Is that really fair? People said, oh, yeah, people are pleading guilty. Yeah, so those people are criminals. So you're gonna take the word of criminals over me. So those people pleading guilty to their own crimes, and they're saying (because they get a lesser sentence), I gave the mayor cash. Where's the proof?"

I believe the city council has voted to remove you from office temporarily?

A: "They want me to agree to be like a stay-at-home mayor. Well, first of all, I'm not going to sit at home and get a paycheck from taxpayers. That's not going to happen. I don't believe in that. That's not fair. I'm not going to sit at home, collect money from the city to not do my job. And I think the best example of me doing my job, and like capability, is I have shown up to work every single day, literally the day after the first indictment and the Monday after the second one.

The other thing is, the council is using a part of the charter that they're misinterpreting. The charter does not say that a council can remove a mayor by seven votes for any reason. It's specific to if the mayor is like incapacitated, a mayor gets into a car accident, or they're in a coma. Someone still needs to run the city. The council can then, because someone's determined the mayor cannot perform his or her duties... it is not to remove someone because you don't like them."

We turn to Coogan, and the "multi-person race" audio.

What makes you a better candidate than Coogan, who did very well in the preliminary?

A: "I don't think people are excited about him as a mayor. I don't think they're excited. I think that was the backlash of exhaustion from what's going on. And I think that that was designed to do exactly what happened. I think the timing of the second indictment was strategic. 11 days before preliminary election. I mean, come on. I've been, I've been a mayor for three years. He's never been a mayor. So who has more experience being a mayor? Me. Who has the track record of getting rid of fees? Me? Who has the track record of making sure that teachers, police officers, and firefighters are not getting laid off, the rather, we're adding to their forces? Me. And I tell people, you know, Mr. Coogan was a vice principal. Nothing wrong with vice principals. That's great. Where was he when his own colleagues, his own teachers, were getting laid off year, after year, after year? I didn't see him fighting then. I didn't see him going to city council meetings to say, 'Hey, we can't lay off these teachers.' He wasn't a champion for his own staff. Why? Because he had a

pension. He was all set. He lived in Somerset, for the majority of his life, 20 something years, paying Somerset taxes, paying for their school system, their police officers, their firefighters, their roads, and only moved back to Fall River two and a half years ago And wants to run the city? I'm not saying that I'm the best person for the job, but in this race, I am the best candidate."

I saw a few days ago "The Herald" reported on some leaked audio from your campaign meeting. What did you mean by a "multi-person race"?

A: "The Herald News' picks and chooses what they want to say. So we have a conversation like that. It's a private conversation. But it got leaked, and I'm not mad about it. It happens. But the reality is I told them that we are winners. We've been winners, and we still need to win November 5. But, at the end of the day, winning is not about Jasiel Correia. Winning is about the city of Fall River winning. It's always been about the city of Fall River. So, I told my supporters that may mean another candidate wins. Because I feel so strongly that Paul Coogan should not be the mayor. So, I know that that vote total for him was not because people were thrilled about him. I don't blame people. I understand. It's a hard sell to say reelect the guy that's been indicted two times. I know that, I understand, But that doesn't mean that this other guy is the best choice either. So what I said in my meeting, is that if a third, or fourth, or fifth candidate comes out, my supporters are encouraged to help them. Because if we, if we can't win, that doesn't mean we should just let the other guy win. I'm running against him. So why would I want him to win? But see, what happens is people want to poke a headline and make it sound like I was conspiring to rig the election. I heard a lot of people say that, but indicting me 11 days before election is not rigging the election."

Say you beat the charges and manage to win reelection, what do you have in the works for the city?

A: "I think transportation is probably my biggest concern. We want to create a kind of inner city loop, free. Inner city hop-on, hop-off loop. It's more like a tram. You hop on, and it takes you to only certain spots, but really cool neighborhoods, and it connects you to the train. So, I think that's a pretty exciting opportunity where people could hop on, grab lunch downtown, go back to school, whatever it may be. And I'm not just talking about BCC, I'm talking about all the other stuff going on in downtown. But really, it's about creating a vibrant downtown, a vibrant city, a vibrant waterfront with more restaurants, more places to hang out."

The Fall River general elections will be held on November 5th. Fall River Mayor Jasiel Correia will not run for re-election and is taking a leave of absence. He remains on the ballot despite not actively running.

PRACTICE WHAT YOUPREACH

COMPUTER SECURITY

For years, I have preached the virtues of security and privacy. Looking back, I realize that I have been lax, when it comes to my own digital well being. Recently, I've made some changes to my computer hygiene, and I'm going to share what I've learned.

CLOSE UNUSED ACCOUNTS

Go through your accounts, and delete any that you don't use. This might seem tedious, but consider that every orphaned account is a security vulnerability. With so many sites and services being compromised every day, it is risky to trust your personal information to an abandoned account.

CHANGE PASSWORDS

Most people create one or two passwords and reuse them on every website they come across. This sort of password recycling leaves you open to compromise. If someone was able to get your gym password, could they guess your Facebook? Or maybe your bank? If someone got access to your email, would they be able to change the passwords to your other accounts? It's a chilling thought, but one that is easy to remedy.

STOP USING BAD PASSWORDS

Adding numbers and symbols to your passwords isn't enough to make them secure. It is as easy to guess Kitty as it is to guess Kitty123 or Kitty123! What looks like a good password fails instantly. Often, it isn't a "person" trying to guess your account, it is a bot or a software program designed to quickly guess letter/number combinations and dictionary words.

USE GOOD PASSWORDS

So what can we do? The answer is to use a password generator. A reliable password generator will

create a pseudorandom combination of letters, numbers and symbols. These combinations are anonymous and unique and are often significantly longer than the passwords that you might think to use on your own. That is because it is much harder to guess a twelve digit random password than a six letter dictionary word.

GET A PASSWORD MANAGER

We all have too many passwords. We need a password storage solution that doesn't involve memorization, sticky notes or paper journals. You need a password manager. Password managers are applications designed to store your passwords in a secure, encrypted manner.

A good password manager is characterized by the following:

- Your password manager should be so secure that you're the only one who has access to it. Not bad guys, not the company that makes the software, just you.
- Makes it easy to enter and manage passwords.
- · Has a password generator built in.
- Be super portable. It should run on every platform that you use natively, including your phones, tablets and online.
- Has a 2FA code generator built it.
 (More on that in a moment).

There are a number of good password managers now. I currently use 1Password. It recently switched to a monthly subscription fee. If that's not your thing, then there are some great free options including LastPass. Whatever you choose, make sure that


it has been vetted by a trusted security expert.

MULTI FACTOR AUTHENTICATION


Multi factor authentication is a technology that requires you to have two or more things in order to access an account. These two things usually are comprised of something you know and something you have. The "something you know" is probably your password. The "something you have" might be a fingerprint, a USB thumb drive or your phone. In the case of your phone, you might receive a text message, or a secret code, when you try to sign in. That means that even if someone besides you, who doesn't have your phone, figured out your password, they wouldn't be able to sign in. A lot of sites are starting to offer multi factor authentication now, including iCloud, Google, Facebook, Twitter, Dropbox, Snapchat and more. I turned it on for every account I could and will be keeping an eye out for more in the future.

CONCLUSION

It is important to remember that you are only as secure as your least secure attack vector. I am not someone who cares to look over my shoulder, and I am not paranoid about "hackers," but I do like my technology to work the way I expect it to. Computer security is not just another brick in the building, that is our digital life. It is in many ways the cornerstone that holds the whole thing together.
